SELECTION

RULES AND REGULATIONS

Membership: The applicant's parent(s) or legal guardian(s) must be an active member of Henry County REMC.

Student Status: The applicant must be a graduating high school senior who will enroll full-time in an accredited college, university, or qualifying vocational or technical school during the next academic year. (A qualifying vocational or technical school is one whose credits are transferable to a state-accredited college.)

Application Submission:

Applications must include all requested forms and an official high school transcript. Completed applications may be submitted electronically through the HCREMC website or mailed/delivered to: Henry County REMC, 3400 S State Road 3, P.O. Box D, New Castle, IN 47362. Applications must be received no later than **February 6, 2026**.

If submitting by mail, students and parents/guardians should complete pages 1–3 of the application and provide the full five-page packet to the high school principal or counselor for submission.

For electronic submissions, the scholastic record and student evaluation section *must still be completed by the principal or counselor* and uploaded with the application along with the official transcript.

Supporting Materials: Only the official application, high school transcript, scholastic record, and student evaluation will be accepted. No additional materials or attachments will be considered.
